

Course Information Brochure

SEDA Group offer the SIS50612 Diploma of Sport Development qualification as the Vocational Education and Training (VET) component of the PGA of Australia Golf Performance Program. This program is a joint initiative between the Professional Golfers Association of Australia (TOID: 22044) and SEDA Group, based at the PGA Centre for Learning and Performance at the Sandhurst Club in Victoria. It is designed for students with a strong interest in a career in the golf industry. Students will develop the knowledge and skills to plan, organise and manage a range of programs and services in a golf specific context.

Delivery and Assessment

The qualification is delivered by SEDA Group and Professional Golfers Association of Australia trainers through a combination of methods including face-to-face delivery in a classroom, self-paced learning, supervised workplace training and online study. Students are required to provide their own laptop with Microsoft Office and golf clubs. All remaining essential equipment and facilities will be provided by SEDA Group to complete this qualification.

The assessment of this qualification involves a variety of methods some of which may include: verbal questioning, projects, observation tasks, role plays, written and research tasks.

The assessment of your overall competence will be undertaken by qualified SEDA Group and Professional Golfers Association of Australia assessors and students will use an online system to access, lodge and obtain feedback on assessments. SEDA Group provides a fair and equitable assessment process that includes the option of an assessment re-sit. If a student is not competent after two re-sits; a fee will be charged and students will be required to re-enrol in the unit. This also applies for Recognition of Prior Learning (RPL).

Pathways

After successful completion of the SIS50612 Diploma of Sport Development, students may obtain employment in the golf industry as a Pro Shop Assistant or Manager, program manager, tournament official, coach or sport development officer. In addition, students may use this qualification as a pathway to an undergraduate degree such as exercise science, sports management or physical education or a pathway to the PGA Traineeship Program.

Eligibility

To be eligible individuals must be registered in the PGA of Australia Golf Performance Program. In addition, individuals are required to complete a Pre-Training Review which includes a Language, Literacy and Numeracy assessment prior to commencement of training to ensure the qualification is the most suitable training option and meets their individual needs. Support will be provided to students that have individual training needs. Individuals with disabilities are encouraged to access government subsidised training. Students under the age of 18 will need parental/guardian consent to enrol.

Length of Qualification

The VET component of the PGA of Australia Golf Performance Program is facilitated over 39 weeks commencing from February 2016 to December 2016. Training will be delivered for 3 days per week between Monday and Friday, 8:30am – 4:30pm.

Unique Student Identifier (USI)

From 1st January 2015 all students studying a Vocational Education and Training (VET) qualification or VET unit of competency must have a USI to be issued a qualification or statement of attainment. The USI is a reference number that provides individuals a history of training courses they have participated in with qualifications and units completed. Continuous Improvement

Recognition of Prior Learning (RPL)

Recognition of Prior Learning is a process by which an individual can demonstrate knowledge and competencies currently held, as a result of past experience or training. Individuals can apply for RPL to gain credit towards the qualification they wish to enrol into. RPL will incur a fee, please refer to the *Schedule of Tuition Fees* on our website.

Credit Transfer (CT)

AQF qualification and statements of attainments issued by any other RTO or AQF authorised issuing organisation or authenticated VET transcripts issued by the Register (USI) will be fully recognised by SEDA Group subject to sighting and verification. This will enable potential students to gain credit transfer prior to course commencement.

For individuals wishing to utilise the VET FEE-HELP student loan scheme, eligibility criteria apply. Eligibility application forms will be provided prior to course commencement.

Prior to enrolment, individuals will receive a *Statement of Fees*, being a detailed quote for this qualification. In addition, all students will be issued with an invoice notice at least 14 days prior to each unit of study census date.

Course Fee Conditions and Refund Policy

SEDA Group's refund policy applies to tuition fees paid for VET units of study that are approved for VET FEE-HELP. It applies to all individuals whether they pay their tuition fees upfront or seek VET FEE-HELP loan assistance.
